#### Minutes of the Annual General Body Meeting

The meeting proceeded and all points of agenda were discussed and resolutions were passed thereof:

1. Mr. Pankaj Munjal, Secretary, welcomed the members.

The President Mr. Pawan Kumar Kakar presided over as chairman of the meeting.

- At the outset, Hon'ble President requested the members attending AGM to pay homage to the departed souls of the resident during last one year by observing One-minute silence.
- 2. Read the minutes of the last Annual General Body meeting of the Society and to note the action taken thereof.
  - > The Secretary Pankaj Munjal presented the minutes of the last AGM and explained the action taken thereof by the managing committee. He informed that whitewashing of stairs work will be taken this year.

### 3. Discussion on annual report of its activities.

- The President informed that beautification work was undertaken near main entrance gate.
- Painting and Fencing work was done at the common boundary wall with Vidya Vihar society for protecting stray dogs' entry from the other side.
- Repairing of pump house and transformer roof was undertaken and a rigorous follow up was done with Power Department.

## 4. Discussion and approving accounts for the financial year ending 31st March 2024.

The president explained the same and informed that one FD ofRs.5,00,000.00 was encashed for the increase in repairs work under taken during the year and increase in liquidity required for the timely payment for the various cleaning and security services undertaken and wages to the other persons engaged by the society. One member raised the queries about the legal expenses. The details of which was provided as follows:

  - ii. Legal Expenses 3000/- (Legal opinion) taken
- After satisfactory explanation, the Annual Audited Accounts was duly approved by the members.

#### 6. To approve budget of whitewash of stairs.

The President informed that whitewashing of the stairs case and the stilt area, which was passed last year could not be undertaken as mumti repairs work was going on. The above work now will be undertaken by engaging the labour on daily basis at an average cost of Rs.6000/- per staircase approximately. The material will be purchased in bulk and will be supplied by the society. All the said expenses will be borne by the society from society fund.

#### 7. To approve construction of floor above society hall.

The President informed that the cost involved is coming quite high so it is suggested to defer this matter.

#### 8. Installation of steel gate in the main entrance.

President also informed that we intend to install a steel gate in the main entrance to in increase the ambience of the society. The next cost of which would be around Rs.100000/- (One Lakh Only) approximately (against Salvage). The same was approved by the house.

#### 9. To discuss V.K. Gupta case.

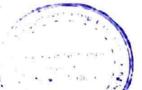
The President informed that Vinod Kumar Gupta has made a new complaint against the society under sec- 70 of DCS Act,2003 for which MC has given a suitable reply. Regarding the recovery proceedings against him, the execution process under the award under sec-71 has now been initiated by the RCS. The expulsion notice under sec 86 has also been initiated against him and first notice has already been issued to him. He further informed that interest @ 15 percent simple has been charged from him from 1/11/2018 onwards and reversal/adjustment entries of Rs. 90,883/- has been passed in his account as is being done in other outstanding accounts also respectively. The same was approved by the house.

### 10. Any other matter with the permission of the chair.

The following matters were also discussed and approved.

Painting work to be done at the park side wall and fencing.

- Fifteen days' notice to be served to remove scrap dumped in still area/society premises by the residents and after that it will be removed at the cost of the concerned resident.
- The owner of vacant Flats to be informed to get the required repairing done.
- The boundary walls of the society to be got repaired.
